Through the Ld. Counsel Mr. Y Suryanarayana for CoC filed a Counter and initially opposed the application on the grounds stated therein, when the matter has come for passing orders today (17.10.2022), Ld. In case, the records are not delivered within two days by the out-going Resolution Professional, the same also be brought to the note of Resolution Professional. The new Resolution Professional shall ensure that the CIRP is continued as expeditiously as possible and shall take all steps to avert the delays if any in completing all the CIRP.

The out-going Resolution Professional Mr. Raj Kumar shall inform IBBI about his decision to withdraw his Authorization for Assignment (AFA) within 7 days from today.



The Resolution Professional dues if any payable, shall be settled within a week from the date of the order. We give the liberty to former Resolution Professional to approach this Adjudicating Authority.

Accordingly, the IA is disposed of. Rest of the IAs are posted to 17.11.2022.
